- WHEREAS,** the Washoe Tribe of Nevada and California adopted the Stewart Community Articles of Association on September 5, 1990, by resolution 90-W-34, which gives the Stewart Community Council authority to promote and protect the welfare of the Stewart Community and its membership; and
- WHEREAS,** the Stewart Community Council has a need to select (4) Stewart Community Council Members for the upcoming 2022-2026 Council Term; and
- WHEREAS,** the Stewart Community Council voted and appointed Mr. Darrel Kizer to represent the Stewart Community as a Community Council Member, pursuant to the Stewart Community Council Articles of Association, Article III, Section 2 at its meeting on October 18, 2022; and
- WHEREAS,** the Stewart Community Council does hereby appoint Mr. Darrel Kizer as a Community Council Member for the Stewart Community.
- BE IT RESOLVED THE WASHOE TRIBAL COUNCIL** that the Stewart Community Council Resolution No. SCC-2022-007 for the appointment of Darrel Kizer as a Community Council Member for the Stewart Community is accepted and approved.
