GENERAL FUND (FUND 1000 & CORRESPONDING FUNDS)**

WHEREAS, the Washoe Tribe of Nevada and California, is organized pursuant to the Provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984), as amended, to exercise certain rights of home rule and to be responsible for the general welfare of its membership; and

WHEREAS, in accordance with Article VI, Section 1(i) of the Constitution of the Washoe Tribe of Nevada and California, the Washoe Tribal Council has the power and duty to approve annual budgets for the Tribe; and

WHEREAS, the General Fund Revenue Budget presented to Tribal Council was in the amount of \$2,944,977; and

WHEREAS, the CFO recommended the proposed figures for the General Fund Revenue Budget; and

WHEREAS, the Tribal Council has reviewed the General Fund Revenue Budget Package provided by the CFO and has approved the 2025 General Fund Revenue Budget attached hereto.

BE IT RESOLVED BY THE WASHOE TRIBAL COUNCIL that it hereby approves and adopts the 2025 General Fund Revenue Budget.


CERTIFICATION

RE: Finance Officer's Budget Message for 2025

Attached hereto is the 2025 operating revenue budget proposal for the Washoe Tribe of Nevada and California. The budget information presents the overall projected revenue resources for the General Fund.

One of the Washoe Tribe's strategic objectives is to promote financial stability through planning and maintenance of the Tribe's resources. The 2025 revenue budget is a key component in the achievement of the Tribe's vision statement below:

Preserving, reviving and living the Washoe culture and traditions. Where: Respect for one another and tribal values promote our spiritual, physical and environmental wellness. Educational opportunities are available for all tribal members and descendants. A solid economic foundation ensures self-sufficiency for tribal success. Responsive government promotes teamwork, professionalism and accountability. On safe and secure tribal lands.

In 2024, the Tribe's ARPA and COVID-19 supplemental funding continued to diminish and end. This has caused the Tribe to start pivoting to more normal operations similar to 2019 and before where the growth of the Tribe relied on grants, taxes and cooperative efforts. Further, economic conditions continued to put pressure on the Tribe financially with inflation elevated, US elections/policy changes and consumer confidence neutral. The Tribe continued investing resources in adding more grants, structuring the Tribal government and enterprises separately, and maximizing its current financial resources and connections with outside agencies. In addition, the Tribe has worked to increase its presence and widen its footprint culturally.

The financial forecast for 2025 hints at further challenges but also new opportunities for the Tribe to maneuver and adapt. The need for continued capacity to help manage the diverse financial portfolio will be a priority. Effective communication at all levels of the Tribe including membership, administration, departments and partners to strategically focus attention on specific initiatives to further the growth of the Tribe. I am optimistic that the Tribe will continue to adjust and implement practical approaches on its journey through the year.







SALES & USE TAXES BY STORE (2020 - 2025)




EXCISE TAXES BY STORE (2020 - 2025)

Dear Tribal Leaders,

Please find attached a preliminary draft of proposed legislation aimed at streamlining the Tribal Nation Grant Fund (TNGF) process and ensuring quarterly equal distribution grants to all RSTF-eligible tribes. This draft reflects tribal leader direction to distribute most - but not all - monies for equal distribution grants while retaining some funds for large one-time grants. We invite feedback from tribal governments on this proposed language. CNIGA will discuss the draft language at its October 17 meeting. Additionally, the draft language will be discussed at the November 13 All Tribes meeting with the goal of finalizing it by year's end.

Why It Matters:

A consistent and mandatory equal distribution grant from the TNGF would help increase and stabilize funding for nongaming tribes. Depending on annual inflows into the TNGF, this could result in more than \$600,000 being distributed to RSTF eligible tribes, bringing annual totals to more than \$1.7M per eligible Tribe.

Background:

On May 23, TASIN and CNIGA hosted an All Tribes Meeting in Sacramento where funding for RSTF-eligible tribes was on the agenda. Following comprehensive presentations on the Revenue Sharing Trust Fund (RSTF) and Tribal Nation Grant Fund (TNGF), including their backgrounds and conditions, tribal leaders completed a brief survey. The vast majority expressed support for streamlining the TNGF and distributing available funds as equal distribution grants. Tribal leaders discussed possible legislation sponsored by TASIN and CNIGA to help make improvements to the TNGF.

Following the May 22 All Tribes meeting, TASIN hosted a workgroup to identify potential amendments to AB 880 (statutes of 2017) - the bill which established and set forth the grant process for the TNGF. On June 14, CNIGA hosted an RSTF Working Group Zoom meeting to further discuss recommendations and concepts.

The issue was again discussed at the June 20 CNIGA meeting, where leaders voted to support distributing most - but not all - monies for equal distribution grants while retaining some funds for large one-time grants. CNIGA members also voted to support timing the equal distribution grants with the quarterly RSTF payments. However, comments and feedback on these policies

were limited. The issue was further discussed at the August CNIGA meeting at Yocha Dehe where key provisions of proposed legislation were presented. Several questions for feedback were posed, including: (1) are the key provisions of the proposed legislation consistent with what eligible tribes want to see? (2) Are there other changes to the TNGF eligible tribes want to see? (3) What percentage of TNGF monies should be reserves for large, one-time grants?

We look forward to seeing you at one of the upcoming meetings (Oct. 17 CNIGA or Nov. 13 All Tribes) and hearing your feedback on this proposed draft language.

2025 RECOMMENDATION

Based on the California Nations letter to Tribal Leaders, the \$600,000 from the (TNGF) Trial Nations Grant Fund is being distributed to non-gaming Tribes in the form of a grant. This is the same distribution pot of funds as the (RSTF) Revenue Sharing Trust Fund that the Tribe uses to support the general fund \$1,100,000.

I recommend that if the proposed legislation moves forward and it is finalized that the (TNGF) funds are included as automatic distribution, that these funds go towards the general fund to be consistent with the (RSTF) funding bringing the total up to \$1,700,000 total to be used. This would help communities and departments service the Tribal membership with more funding for resources and initiatives.

In the event that this is not passed into legislation, but the “Equal Distribution Grant 2025” is made available, that the Tribe prioritize this funding application for items that were not funded fully in the general fund because of current budget constraints.
